National Treasury Maximum Tax Rate on Long-Term Capital Gains -In 2013 and 2014, the tax rate on net long-term capital gains for individual taxpayers is 15% (or 0% for taxpayers in the lower two tax brackets). Taxpayers with net long-term capital gains exceeding the threshold amount for the 39.6% income tax bracket are taxed at a rate of 20% for those gains.
